6/06/08 HAVING REVIEWED THE MATTER, THE COURT FINDS AND ORDERS AS FOLLOWS:

1. APPELLANTS' MOTION TO GRANT PRELIMINARY INJUNCTION, AS A STAY, PENDING APPEAL OF THE TRIAL COURT'S DENIAL OF PRELIMINARY INJUNCTION IS GRANTED WITHOUT BOND. THE EFFECT OF THE STAY IS TO GRANT APPELLANTS A PRELIMINARY INJUNCTION, UNTIL FINAL RESOLUTION OF THIS APPEAL, THAT PREVENTS APPELLEES FROM INVALIDATING THE LICENSES OR IDENTIFICATION CARDS OF THE CLASS MEMBERS, AS DEFINED IN THE TRIAL COURT'S APRIL 9, 2008 ORDER, IF SUCH INVALIDATION IS BASED SOLELY UPON THE EXISTENCE OF A DISCREPANCY "WITH (THE CLASS MEMBERS') NAMES ON FILE WITH THE BMV AND THEIR NAMES ON FILE WITH THE SOCIAL SECURITY ADMINISTRATION."

2. THE BRIEFING IN THIS CASE SHALL FOLLOW THE INDIANA APPELLATE RULES.
